



### **2016 Financial Snapshot**


We continue to have stable, positive operating performance, with nearly 80% of revenue going to support programs and services.




### Total Operating Expenses: \$14,318,144

We continue to serve the most vulnerable in our community, with the highest rate of uninsured in the state.




4 Out of 5 of our patients have income under 200% of the Federal Poverty Level \*

### **Our Key Achievements this Year**



Completed construction & moved into Joseph M. Smith Building in Brighton, a new 48,000 square foot state-of-the-art facility designed to support patient centered, integrated care

Enrolled over 10,000 individuals in health insurance, including many from the community who are not CRCH patients

Received quality improvement bonus funding for being in top tier for health centers nationwide on access to prenatal care, cervical and colorectal cancer screening rates, childhood immunization rates, and % of diabetic patients in control

Awarded grant funding for dental expansion and launch of new Dental Integration Navigator role, to better integrate oral health and primary care

> Launched on-site Mobile Market program to bring free produce to patients & their families and address food insecurity

Expanded pharmacy hours into evening & weekend hours to improve medication access


