

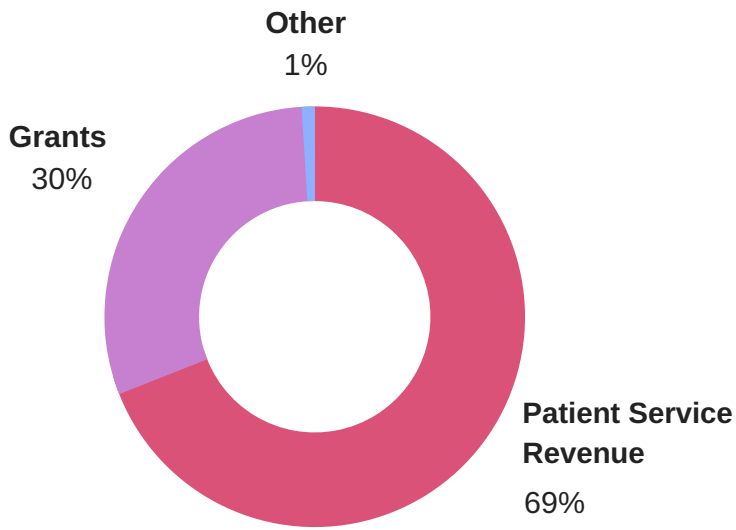

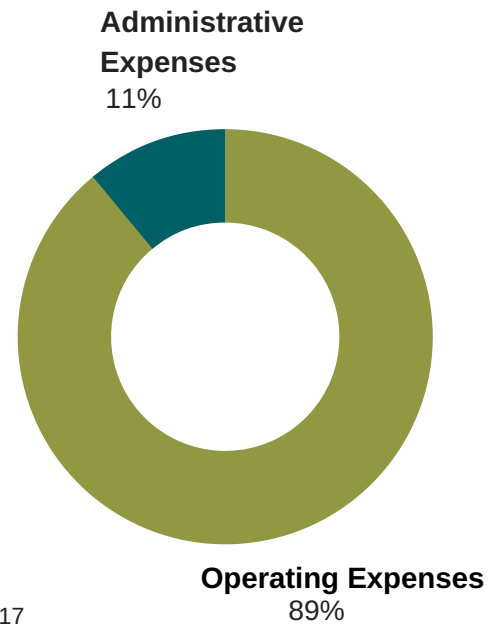

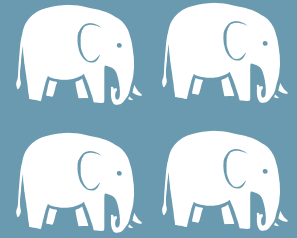

Key Achievements

Distributed 55,392 lbs of fresh produce free-of-charge to our patients through the Mobile Market program, a collaboration with Greater Boston Food Bank (55,391 lbs is equivalent to the weight of 4 elephants!)



CRCH received the National Committee for Quality Assurance's Patient-Centered Medical Home Level 3 recognition, as well as the PCMH PRIME Certification - PRIME Certification demonstrates our success in integrating behavioral health care into a patient-centered primary care setting.



Our Waltham health center will be relocating to a larger and newer facility in early 2018. We held a successful fundraiser in June to kick off our construction project and we look forward to serving even more patients in the new facility.



Starting in 2017, we launched the Call Us! campaign to encourage patients who are sick to call our 24-hour line or to come to CRCH rather than go to the emergency room.



Responding to our patients' needs and requests, we have partnered with a local immigration attorney to offer free immigration legal workshops and consultation sessions for our patients.



Continue preparation work to participate in the MA Medicaid Accountable Care Organization program. CRCH is a part of Community Care Cooperative ACO, which is the only ACO that is comprised of all health centers. C3 is committed to providing more opportunities for individuals to receive coordinated, holistic, and culturally appropriate care in the communities where they live and work.



Piloted a CSA Farm Share program to offer free produce to patients who are eligible for SNAP benefits. Produce was delivered to CRCH weekly during the growing season, and patients conveniently picked them up on site.
