Dear Friends,

Charles River is a special place. You can feel it in the waiting area on busy days with dozens of patients speaking softly in many languages. They are working men and women on a break from the job, moms with kids in tow, and older patients quietly waiting to see their doctor or dentist. You can also see it in the smiles and genuine warmth of the staff, many of whom are from the same communities as the patients we serve. I thought this was a special place before my first day in December 2024. Now I feel the joy every day of working with wonderful people doing meaningful work. I owe a debt of gratitude to Liz Browne, our Board of Directors, our employees, and the community for this opportunity.

We are not a perfect place. Our single biggest challenge in 2024 was turnover among staff. When doctors, therapists, optometrists or any provider leaves, the patient loses that trusted relationship. It's not just providers. All staff members make vital contributions to our work. For these reasons, retention is one of our primary goals. We have implemented new initiatives – such as our employee emergency assistance fund – to show that we value contributors at all levels and to make a tangible impact on their well-being. Our focus on retention is starting to make a difference.

Despite our challenges, we do some amazing work. You'll read in this report some of the numbers: 57,000 visits for 13,500 unique patients, most of whom are poor and prefer to be served in a language other than English. Behind the numbers are real stories, like the young mom, born in Guatemala, who works as a bank teller and brings her baby to us for care.

This is a difficult time for us and for our patients. We trust that decades of bipartisan support for health centers will eventually prevail, but we take nothing for granted. Now, more than ever, we are grateful for your unwavering support.

# **ABOUT US**

Founded in 1974 by Allston-Brighton community activists under the leadership of Joseph M. Smith, our community health center has grown from a two-room clinic to a fullservice, freestanding health center with three clinical sites located in Allston-Brighton and Waltham. In 1997, we moved to a stand-alone site located a block from the public housing complex where it originated. In 2004, we opened a site in downtown Waltham to fill the void left by the closing of Waltham Hospital. In the spring of 2008, we opened a satellite sites at the Gardner Pilot Academy to bring additional access to care to the community. In Fall 2015, we moved into a new state-of-the-art facility in Brighton and in February 2018 we relocated to a new site in Waltham. In 2024 we celebrated 50 years of serving the communities of Allston-Brighton, Waltham and the surrounding areas.





I am a Venezuelan dentist who moved to the USA 21 years ago to learn English. After mastering the language, I pursued a post-doctoral program at Boston University in Restorative and Esthetic Dentistry. I fell in love with the area, married my wonderful husband, Vicente, and we now have two amazing children, Lucas and Sebastian. I'm excited about the work we do and our commitment to helping everyone maintain healthy smiles!

I recall helping a wonderful 70-year-old patient who had several medical conditions and had been living without any teeth. Despite his efforts to find dental care at other practices, his insurance didn't cover the treatments he needed. What made this case even more special was that he was from Guatemala where having a

gold tooth is considered a beautiful and culturally significant addition. I was thrilled not only to provide him with a full set of teeth but also to include the special gold tooth he had desired. I'll never forget the joy on his face when I fitted him with his new dentures.

Moments like these remind me why I love what I do! As an immigrant, I can relate to many of our patients, and I'm incredibly grateful for the sponsorship I received from CRCH 17 years ago. I feel fortunate to have found this special place and I absolutely cherish my patients and my amazing team! My patients are the heart of what I do; they inspire me every day and motivate me to keep going.

I was born and raised on Long Island as a free-range child of the 60's and 70's. While in high school, I started a monthly satirical newspaper with my friends ("The Smithtown Bull") and ran track and cross country. I went to college at Johns Hopkins and then medical school at NYU. I found my calling in caring for underserved populations while doing rotations at Bellevue Hospital in New York City. I did my residency at Boston City Hospital where I met my wife Rebecca while we were pushing patients through the basement tunnels. We have two children, Elena and Tommy. Both are brave world travelers who are following in the medical footsteps of their parents (but on the west coast as far from their parents as possible!). Elena is an interventional radiologist who will support her parents in their old age and Tommy is a family medicine intern who will replace






